# HIGH CHAIRS

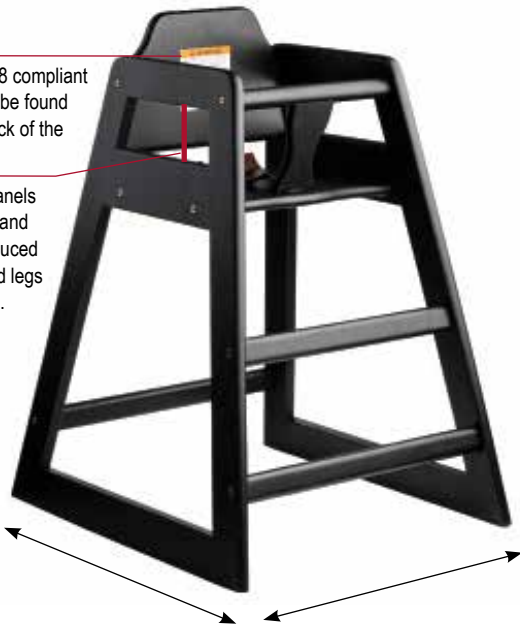
- ASTM404-18 Compliant

- Permanent passive restraint added to the front of the chair
- Reduced all gaps in side panels and seat back to reduce the risk of fall through
- Increased stance for added stability and reduced risk of tipping
- Durable construction with reinforced fittings
- Available pre-assembled or shipped flat
- Assembled unit is subject to dimensional weight charges, UPS ships oversize

The gaps of side panels between arm rests and seat have been reduced to prevent arms and legs from getting lodged.

Split washers will be used with all bolts to prevent them from loosening. 



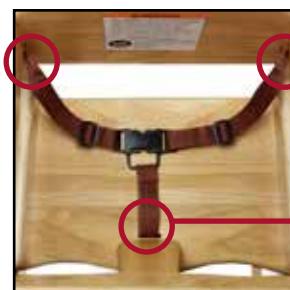
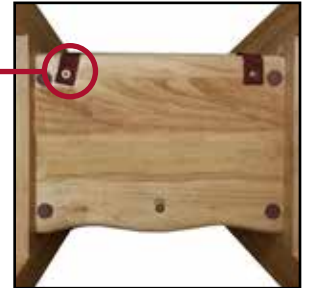

### Important Note:

The 3-point seatbelt assembly may differ slightly due to manufacturing method. Please be assured, both versions are ASTM certified. Replacement strap assemblies listed below are based on how assembly attaches to chair.\*




**Primary attachment system:** 3-point seatbelt with side belts attaching to bottom of chair's seat and center belt secured between the center bar of the seat. Use Replacement Strap Assembly A\* (Item #676767).



**Alternate attachment system:** 3-point seatbelt with side belts attaching to chair's back panel and center belt passing through and affixed to bottom of chair's seat. Use Replacement Strap Assembly B\* (Item #676766).
