Mixers Limited Warranty

Globe Food Equipment Company ("GFE") warrants to the original purchaser of new equipment that said equipment, when installed in accordance with our instructions within North America and subjected to normal use, is free from defects in material or workmanship for a period of two (2) years. Warranty begins on the date of factory shipment to an end user, or up to six (6) months after factory shipment to a dealer or distributor.

Mixer attachments, such as bowls, beaters, hooks and whips, have a one (1) year parts only warranty. Hub attachments, such as shredders, slicers and grinders, have a one (1) year parts only warranty.

THIS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESSED OR IMPLIED. GFE EXPRESSLY DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY OR EXPRESSED OR IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE.

GFE'S OBLIGATION AND LIABILITY UNDER THIS WARRANTY IS EXPRESSLY LIMITED TO REPAIRING OR REPLACING EQUIPMENT AT GFE'S DISCRETION WHICH PROVES TO BE DEFECTIVE IN MATERIAL OR WORKMANSHIP WITHIN THE APPLICABLE WARRANTY PERIOD. IN NO EVENT SHALL GFE BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES TO BUYER OR ANY THIRD PARTY, INCLUDING, WITHOUT LIMITATION, LOSS OF PROPERTY, PERSONAL INJURY, LOSS OF BUSINESS OR PROFITS OR OTHER ECONOMIC LOSSES, OR STATUTORY OR EXEMPLARY DAMAGES, WHETHER IN NEGLIGENCE, WARRANTY, STRICT LIABILITY OR OTHERWISE.

All repairs pursuant to this Warranty must be authorized by GFE and performed by a GFE designated Service Agent during their normal business hours. For authorization contact Technical Support at 1-866-260-0522.

This warranty is given only to the first purchaser from a retail dealer and it not transferable or assignable to any subsequent owner.

Items not covered under warranty, but are not limited to:

- Acts of God, fire, water damage, burglary, accident, theft, vandalism
- Freight damage
- Residential installations
- Improper installation or alteration of equipment
- Use of generic or after market parts
- Repairs made by anyone other than a GFE designated servicer, or not pre-authorized by GFE
- Improper Lubrication
- Expendable wear parts, belts, polycarbonate splash covers, power cords
- Cleaning of equipment
- Misuse or abuse
- Failure to maintain as described in operation manual
- Missing, lost, broken parts

Service under this warranty shall not be made available until a properly completed and signed Installation/Warranty Registration has been received by GFE. Installation/Warranty Registration must be received within 30 days from the date of installation.

THE FOREGOING WARRANTY PROVISIONS ARE A COMPLETE AND EXCLUSIVE STATEMENT BETWEEN THE BUYER AND SELLER. GFE NEITHER ASSUMES NOR AUTHORIZES ANY PERSONS TO ASSUME FOR IT ANY OTHER OBLIGATION OR LIABILITY IN CONNECTION WITH SAID EQUIPMENT.
